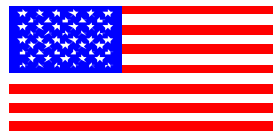

Pursuant to Section 2(6) of the Marshall Aid Commemoration Act 1953,
we have the honour to submit the report of the
Marshall Aid Commemoration Commission for the year ending 30 September 1997.

INTRODUCTION

As a way of expressing Britain's gratitude to the American people for the Marshall Plan, the British Parliament passed an Act in 1953 which founded the Marshall Scholarships.

These Scholarships enable young Americans of high academic ability to study for a degree at a British university, either at undergraduate or graduate level. The scheme allows the students, who will one day become leaders, opinion-formers and decision-makers in their own country, to gain an understanding and appreciation of British values and the British way of life. It also establishes long-lasting ties between the peoples of Britain and the United States. Up to 40 new awards are offered every year. Each one is held for two years and may be extended for a third year.

The programme is administered in Britain by the Marshall Aid Commemoration Commission and in the United States by the British Embassy in Washington DC, and the Consulates-General throughout the US. The Prince of Wales is Honorary Patron of the Association of Marshall Scholars.

MEETINGS AND MEMBERSHIP

Regular business meetings of the Commission, under the Chairmanship of Dr Robert Stevens, Master of Pembroke College, Oxford, were held on 7 October 1996 and 20 January and 25 April 1997.

No new members were appointed to the Commission during the year under review. Professor Lord Desai completed his term of appointment on 31 July 1997, while Professor Harry Dickinson and Ms Sue MacGregor completed their terms of appointment on 31 August 1997. The Commission is indebted to these members for their help, advice and dedication.

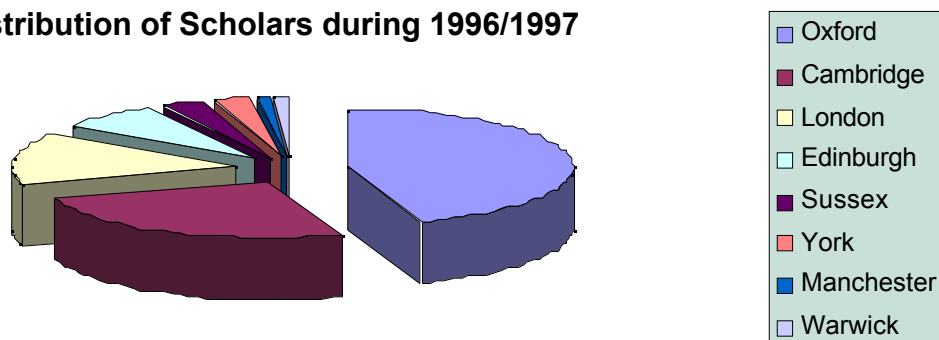

SCHOLARS IN BRITAIN 1996/1997

At the start of the academic year 1996/1997, 87 Marshall Scholars were in residence at British universities. This number was made up of 11 1994 Scholars, who were completing a third year, and groups of 36 and 40 who had taken up their awards in 1995 and 1996 respectively. The total group comprised 56 men and 31 women. Three of the Scholars were married (1 man and 2 women), the spouses of all of whom were in residence in the UK.

The distribution of awards was as follows: 39 at Oxford, 22 at Cambridge, 13 in London (3 each at Imperial College and the London School of Economics, and one each at the Courtauld Institute of Art, Goldsmiths College, the Institute of Neurology, King's College, the London School of Hygiene & Tropical Medicine, the Royal Academy of Music, and the School of Oriental & African Studies), 6 at the University of Edinburgh, 3 at the University of Sussex, 2 at the University of York, and one each at the Universities of Manchester and Warwick.

Distribution of Scholars during 1996/1997



As had been the trend in recent years, the majority of Scholars had chosen postgraduate programmes, with 71 enrolling for taught and research graduate degrees; 16 Scholars were registered for a second Bachelor degree or other preparatory undergraduate course.

Fifty-six Scholars were pursuing courses in the Arts and Social Sciences and 31 in Science and Engineering, including Mathematics. The range of individual subjects studied in the year under review showed a slight decrease from the previous year (54 as compared with 56). The subjects chosen were as follows:-

SCHOLARS GRADUATING IN 1997

Thirty-five Scholars completed tenure of their awards in 1997. Of these, 20 had graduated at the time of completion. The remaining Scholars, who are registered for research or taught Master's programmes, will complete the requirements for their degrees in the coming months.

The successful graduates comprised 3 1994 Scholars (one completed a Doctor of Philosophy, one a Master of Studies and one a Bachelor of Arts), and 17 1995 Scholars, whose results were as follows:- 5 Master of Philosophy, one Master of Arts, one Master of Letters, 4 Master of Science, one Bachelor of Philosophy, and 5 Bachelor of Arts (all at Oxford; 2 with first class honours and 3 with second class honours, upper division).

The examination results of 16 former Scholars were announced during the year - one from the 1989 group, one from the 1990 group, 4 from the 1992 group, 4 from the 1993 group, and 6 from the 1994 group; 8 of these obtained a doctorate and 8 took a Master's degree.

The names of all Scholars on whom degrees were conferred during 1996/1997, together with their results, are listed at the end of this Report (Appendix II).

Five Scholars from the 1995 group were granted an extension of their award to a third year of tenure, either on full or partial funding, and will continue their studies in 1997/1998:- one at Edinburgh, 2 at Cambridge and 2 at Oxford. In addition, the Commission is particularly delighted to report that the costs of a third year of tenure for 3 1995 Scholars at the University of Cambridge will be underwritten by the Cambridge Overseas Trust under the terms of a new arrangement between the Trust and the Commission.

The arrangement was made during the year under report and, with effect from 1996/1997, the Trust has agreed to underwrite the costs of a third year for up to three Marshall Scholars at Cambridge each year. To be eligible for Trust funding, Scholars must have been registered for a PhD from the outset of their tenure

at Cambridge and require not more than one year in which to complete their doctorate. They are also required by the Trust to apply for alternative sources of funding for which they are eligible.

Three of the 1996 Scholars resigned their awards after one year's tenure, all of whom were able successfully to complete the requirements for a degree before returning to the United States.

SCHOLARS' WELFARE

The Commission's efforts during 1996/97 were, as always, largely concentrated on the selection and placement of Scholars. Much energy was also devoted to helping the Scholars make the best use of their awards and derive maximum benefit from their time spent in the United Kingdom. Every encouragement was given to Scholars to keep in contact with and to visit the secretariat whenever possible, whether for help on academic and other matters or on a social basis; also, some visits were made by members of the secretariat to Scholars at their universities.

Tutors and supervisors were asked to provide progress reports at the end of the academic session and, as is customary, the Scholars themselves submitted annual reports. These reports, which are confidential to the Commission and members of the selection committees in the United States, are invaluable in allowing Scholars and tutors to comment freely on both favourable and less successful aspects of a particular tenure.

The Commission takes very seriously Scholars' comments about any difficulties encountered in their academic programme and brings such problems to the attention of the institution concerned when such action appears necessary.

One supervisor at Oxford said of his doctoral student, "It is a pleasure to write a report on X who has been an exemplary student. From the moment he came here I was struck by the confidence and brio with which he addressed his research. His work is sophisticated, analytical and original and stands up well to commentaries of much more established academics in the field. I do not normally write in such fulsome terms, but I believe X is an exceptionally gifted student who has made exemplary use of the award granted him by the Marshall Commission".

One tutor at Sussex wrote, "We have been most pleased to have X among us these past two years and believe that there has been a real exchange of benefits in having her here during her studies. We hope that others receiving Marshall Scholarships will choose to come here

A tutor at Cambridge commented, "I am very pleased to report on the progress of X. She is a hardworking, able and mature student who has impressed all her supervisors with her enthusiasm, progress and her approach to her work. Outside her work, X has entered fully into the life of the College and the University".

One supervisor at the University of Manchester said how delighted he was that "X had made a real contribution to the research of the group here at Manchester, and to the OPAL collaboration at CERN; we are extremely pleased, and those responsible for the selection of Marshall Scholars can be equally pleased with their choice".

Of his Physics student at King's College, London, a tutor wrote, "Throughout his time here he has been an outstanding student. He won several departmental prizes for his work and, [on graduating with a First Class Honours degree] has been awarded the University of London 1997 Prize in Physics. X has exploited the opportunities of the British Marshall Scholarship and has been a very strong asset to this department".

A supervisor at Cambridge commented, "In brief, X has more than lived up to my high expectations. He has worked hard, has been a real 'team player' and has contributed greatly to the laboratory intellectually. He will be sadly missed when he returns to the USA".

One Scholar at Edinburgh said, "This year has been perhaps the most eventful, enjoyable year of my life. I have grown both emotionally and intellectually in Edinburgh and feel that Scotland is a place I will always remember and a place to which I will always wish to return. The Marshall Scholarship has been an incredible opportunity."

Of her time at Oxford, one Scholar wrote, "My experience has been invaluable from an academic as well as social perspective. The past two years have presented opportunities that have been informative, enjoyable and productive."

Another Scholar at Oxford said, "It is quite difficult to encapsulate and summarise the extent and variety of my experiences during my tenure as a Marshall Scholar. In fact, I believe that I shall be re-visiting, re-living and re-writing my experiences at Oxford and the rest of the UK for many, many years to come. Conversely, I feel that these same experiences will impact my future life in perhaps subtle ways that I may not currently recognise or foresee."

A Scholar at Sussex commented, "My two years in Britain have been an intellectually and personally enriching experience. My time here has been an important phase in my life and will serve as a springboard from which to explore new opportunities in the future".

Of her time in London, one Scholar said, "Choosing a favourite aspect of my time here would be difficult. I have thoroughly enjoyed the novelty of studying abroad and forming international friendships that I know will be lasting. I look forward to another year to continue my course of study and to strengthen the cross-cultural bonds that are starting to grow".

One Scholar at Cambridge simply wrote, "What a wonderful year!".

Commission members were able to meet the Scholars at a Government Reception held on 2 October 1996 to welcome the 1996 Scholars and, again, at the Annual Lunch given in honour of those completing their awards. The Lunch was held on 12 May 1997 at the Glaziers' Hall (by kind permission of the Worshipful Company of Glaziers). The special guest and principal speaker at the lunch was Lord Howe of Aberavon. The Baroness Symons of Vernham Dean, Parliamentary Under Secretary of State for Foreign & Commonwealth Affairs, also spoke and presented Award Certificates.

In addition to these more formal social events, opportunities also arose during the year for some members of the Commission to meet with and offer informal hospitality to Scholars at their university locations.

As part of the induction week for the 1996 Scholars which took place in early October 1996, HE The British Ambassador in Washington DC hosted the group at his residence. Sir John Kerr, KCMG is pictured below (front row, centre) with the group.

After their arrival in the UK, the 1996 Scholars were taken on a tour of the Houses of Parliament,



arranged through the kind offices of the British-American Parliamentary Group. At the end of the tour, the Scholars met with the then Secretary of the British-American Parliamentary Group, Sir Roger Moate, MP, for a 'Question & Answer' session. Sir Roger Moate is pictured below (front row, centre) with the group on the terrace at Westminster. Professor Linn Hobbs, Chairman of the North-Eastern Regional Committee is also included in the picture (third row from front, fifth from left).



SELECTION OF 1997 SCHOLARS

At the Commission meeting held in October 1996, consideration was given to the budget for financial year 1997/98. Notwithstanding some uncertainty about the likely level of funding for the year, coupled with concern for the needs of those Scholars requiring a third year of support to complete a viable academic programme, the Commission agreed to recommend to the Ambassador's Advisory Council that a full complement of up to 40 new awards should be offered for 1997.

The selection of the 1997 Scholars was completed at a meeting of the Advisory Council held in Washington DC on 2 December 1996. After the necessary places at British universities had been confirmed, the 40 British Marshall Scholarships for 1997 were awarded as follows:-

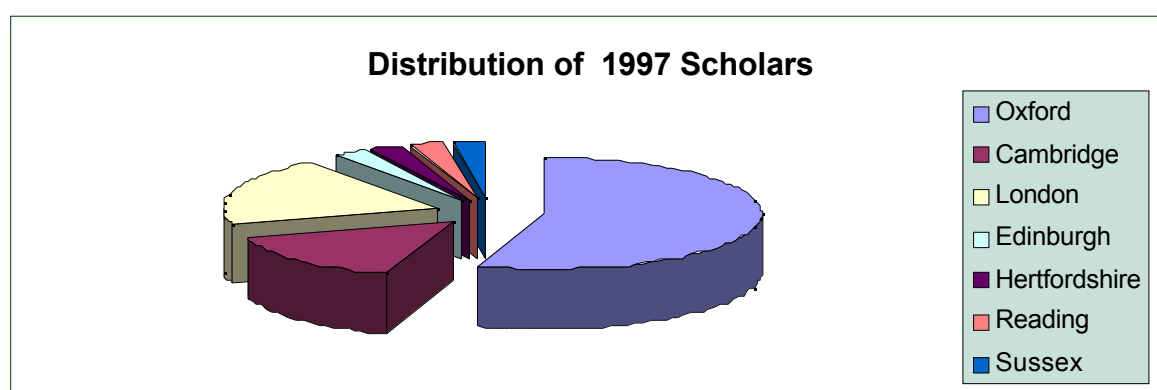

The 1997 Scholars represent 26 different United States universities and colleges, a slight decrease from the 1996 total of 28. Two institutions are appearing in the list for the first time - Gustavus Adolphus College and New Mexico State University. Sixteen of the Scholars are women and the number of scientists is 9.

The group will take up their places at the start of academic year 1997/98 as follows:- 22 at Oxford, 6 at Cambridge, 8 in London, and one each at the Universities of Edinburgh, Hertfordshire, Reading and Sussex. Thirty-three Scholars will read for higher degrees and 7 will be registered for Bachelor degrees or other preparatory courses.



SELECTION AND PLACEMENT POLICY

Once again it has proved difficult to maintain the improvement in the gender balance reported four years ago¹. Similarly, the proportion of Scholars opting for universities other than Oxford, Cambridge and London, which increased in 1993, has fallen again, although it is pleasing to note that placements have been arranged for the first time at Central Saint Martins College of Art & Design, London, the Webber Douglas Academy of Dramatic Art, London, and the University of Hertfordshire. The Commission remains committed to a policy of trying to widen the spread of institutions for take-up of the awards, but, as stated in the past, this is not always compatible with selection of the best candidates and candidates are likely to opt for universities well known in the USA.

THE AMBASSADOR'S ADVISORY COUNCIL AND THE REGIONAL COMMITTEES

The Commission once again expresses its thanks to the distinguished members of the Advisory Council and the Regional Selection Committees in the United States who gave so generously of their time to the programme during the year. The Advisory Council met in Washington DC on 2 December 1996, under the chairmanship of HE The British Ambassador and the Chairman of the Commission. The Commission is particularly grateful to the Ambassador who not only co-chaired the meeting but gave a lunch for the Council members. Ms Hilary Heilbron, QC, attended as the Commission's representative. The Commission records with gratitude the service of Mr Charles Petit who retired as Chairman of the Pacific Committee and member of the Advisory Council after the 1997 competition. The appointment of Professor Hanna Gray (Harry Pratt Judson Distinguished Service Professor of History, University of Chicago) and the Hon. Mrs Janet Yellen (Member of the Board of Governors, Federal Reserve System) to membership of the Advisory Council in 1996 is noted with pleasure.

Full details of the membership of the Advisory Council and of the Regional Committees, as at the date of the 1997 selection interviews, are given in Appendix I of this report.

At the Commission meeting held in April 1997, and with the support of HE The British Ambassador, it was decided that a sixth Regional Centre should be established in the United States with a view to augmenting the current arrangements for the selection of Marshall Scholars. A new South-Western Regional Centre was set up in time for the competition for the 1998 awards. It is based at the British Consulate-General in Houston, Texas, and consists of the states of Arkansas, Colorado, Louisiana, Oklahoma, New Mexico and Texas. The Centre will operate initially for a two-year trial period during which time, for the purposes of clarity, the Southern Region will be known as the South-Eastern Region.

NOLAN COMMITTEE REPORT ON STANDARDS IN PUBLIC LIFE

Following publication of the Nolan Committee Report on Standards in Public Life, much time has been spent discussing its implications for the Commission. In September 1997 the Commission submitted to the Foreign & Commonwealth its three-year Corporate Plan for 1997-2000 as required by Nolan. Other documents, including a Code of Practice for members of the Commission and a Financial Memorandum and Management Statement have also been agreed, while discussions regarding other Nolan requirements will continue.

50TH ANNIVERSARY OF THE MARSHALL PLAN: 5 JUNE 1997

Many events took place throughout the United States and Europe during 1997 in commemoration of the 50th Anniversary of the Marshall Plan. In Britain, one of the highlights was a Reception hosted on behalf of the British Government and people by the Speaker of the House of Commons, The Rt. Hon. Betty Boothroyd, MP. The Reception was held in the State Rooms, Speaker's House, Westminster, on 5 June 1997, to commemorate the 50th Anniversary, to express British gratitude for the benefits of the Marshall Plan, and to underline the continued importance of the transatlantic relationship. A commemorative booklet was produced by the Foreign & Commonwealth Office in time for this event which included a section about the Marshall Scholarships. Commission members and a selection of Marshall Scholars were invited to the Reception, together with representatives of Government and other distinguished guests, some of whom are pictured below.

Another highlight was the speech given at the Annual Lunch held at the Glaziers' Hall, London, on 12 May 1997, by the Commission's special guest and speaker, Lord Howe of Aberavon. He addressed the assembled Marshall Scholars, Commissioners and other distinguished guests and spoke about the ongoing importance of the Marshall Plan in its 50th Anniversary year.

MARSHALL SHERFIELD FELLOWSHIPS

To mark the 50th Anniversary of the Marshall Plan, the Commission was granted funds by the Foreign & Commonwealth Office to establish two one-year postdoctoral fellowships in the field of science and engineering. A suitable framework for the scheme was devised, documentation drawn up, and the competition for awards tenable from October 1998 was launched.

The Fellowships have been named after Sir Roger Makins, FRS, later Lord Sherfield (1904-1996), British Ambassador to the United States from 1953-1956 and the architect of the British Marshall Scholarships programme. The awards, which will be tenable for one year, will each enable an American scientist or engineer to undertake post-doctoral research at any British university or research institute. It is hoped that the Fellowships will introduce American scientists and engineers to the cutting edge of UK science and engineering and that this, in turn, will build longer-term contacts and international links between the United Kingdom and the United States in key scientific areas.

SCHOLARSHIP STIPENDS

Treasury revisions announced from 1 July 1997 resulted in increases to the allowances payable to Marshall Scholars as follows:- basic monthly living allowance from £507 to £517 (and from £608 to £620 for those registered at institutions within the London Metropolitan Police district); book allowance from £339 for first year Scholars and £204 for subsequent years to £346 and £208; marriage allowance from £253 to £259 per month. As a result of the stipend rate adjustments announced with effect from July 1996 the Commission revised the annual grant for approved research travel and the thesis grant from £160 to £165 and from £220 to £225 respectively in October 1996. The rates for these two grants will be further revised in October 1997 following the 1997 stipend increases announced above.

SECRETARIAT

The Commission continued the arrangement under which its secretariat is provided by the Association of Commonwealth Universities, whose offices at 36 Gordon Square, London WC1H 0PF, serve as its headquarters. The detailed work was undertaken by Ms Catherine Reive, Assistant Secretary, under the direction of the Secretary General of the Association, Professor Michael Gibbons, who was the Executive Secretary of the Commission.

EXPENDITURE

The total expenditure of the Commission for the year ended 31 March 1997 was £1,355,261 and a copy of the Account is attached at the end of this report (Appendix III). The figures will be scrutinised by the National Audit Office and, as provided by the Marshall Aid Commemoration Act 1953, the full accounts will be published separately and laid before Parliament.
